WILL OF  
VICTOR UBOLDI

I, REVEREND VICTOR UBOLDI, a resident of San Diego County, California, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I have previously made.

SECOND: It is my desire by this Will to dispose of all my estate situated in the United States, including any bank accounts in institutions located in the United States and any stocks or other ownership interests in any companies, businesses, or funds organized under any laws of the United States of America or under the laws of any of its separate states. I give all of my said estate, as follows:

(1) One-third to my brother GIOVANNI UBOLDI, Via Magenta 14, Turate, Como, Italy, if he survives me for ninety (90) days and, if he does not, his share shall go to my brother PIETRO UBOLDI, Turate, Como, Italy, if he survives me for ninety (90) days.

(2) Two-thirds to my brother PIETRO UBOLDI, if he survives me for ninety (90) days and, if he does not, his share shall go to my brother GIOVANNI UBOLDI, if he survives me for ninety (90) days.

(3) If neither GIOVANNI UBOLDI nor PIETRO UBOLDI survives me for ninety (90) days, both of their shares shall go to the children of GIOVANNI UBOLDI who survive me for ninety (90) days, share and share alike.

(4) My Executor shall represent any child under age 21 in matters relating to any distribution under this Paragraph SECOND, including selection of the assets that shall constitute that child's share, and my Executor may in my Executor's discretion sell for the child's account any part of that child's share.

Any property or its proceeds distributable to a child under age 21 pursuant to this Paragraph SECOND may be delivered without bond to any suitable person with whom he resides or who has the care or control of him. I authorize my Executor to take such actions as he deems appropriate in order to transfer any properties to a resident of Italy.

THIRD: I direct that all inheritance, estate, or other death taxes that may by reason of my death be attributable to my probate estate or any portion of it, or to any property or transfers of property outside my probate estate, shall be paid by my Executor out of the residue of my estate disposed of by this Will, without adjustment among the beneficiaries, and shall not be charged against or collected from any beneficiary of my probate estate, or from any transferee or beneficiary of any property outside my probate estate.

FOURTH: I nominate FATHER DANIEL O'CALLAGHAN and ANTHONY BREGANTE, 6855 Friars Road, Apt. 21, San Diego, California, as Executors of this Will. If one of the named nominees shall for any reason fail to qualify or cease to act as Executor, I nominate the remaining nominee as sole Executor of this Will. The term "my Executor" as used in this Will shall include any personal representative of my estate.

I authorize my Executor to sell, with or without notice, at either public or private sale, and to lease any property belonging to my estate, subject only to such confirmation of court as may be required by law. I further authorize my Executor to invest and reinvest surplus moneys in his hands in every kind of property, real, personal, or mixed, and every kind of investment, specifically including, but not by way of limitation, corporate obligations of every kind, stocks, preferred or common, shares of investment trusts, investment companies, and mutual funds, and mortgage participations, which men of prudence, discretion and intelligence acquire for their own account, subject only to such confirmation of court as may be required by law.

FIFTH: I desire to be buried at Turate, Italy. I authorize my Executor to pay all expenses of transferring my body there and of the burial.

I subscribe my name to this Will this 23rd day of April, 1970, at San Diego, California.

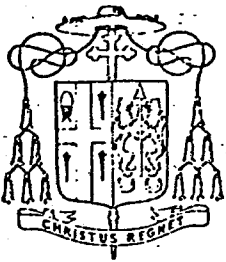
I am very happy with this parish and the people in it, but my life in the rectory is not a happy one due to many circumstances.



Yesterday I received your letter appointing me as Associate Pastor of Rev. Father Mackey. This for me was the saddest news I received since I came to America, and made me very unhappy.

For seventeen years I worked as a missionary in India, always in the same mission. On my return to Italy I was for eleven years in the same Salesian parish and school. In 1956 two of my brothers remained paralyzed due to the Asiatic Fevers. My parents took care of them until they died. Since then I had to take care of them. So my Salesian Superiors although regretting my departure from the Congregation they recommended me to our late Bishop Buddy so that I would be able to help my sick brothers.


In the six and half years that I am in San Diego Diocese I was always sent to parishes where assistants would not remain long, but I always tried my best to stay as long as possible. Finally I was sent to a parish where I am very happy, namely, Our Lady of Guadalupe Shrine, Riverside. The pastor, Father Jazbec and parishioners - Mexican Americans and Negroes - seem to be very pleased with my work, and naturally very disappointed and sad when they heard about my being transferred.

In one of your first talks you said that one of your main efforts will be to make happy your priests. So if you want to make me truly happy, and so also the pastor and the parishioners, please leave me in this parish where I love to work and also feel at home. I will be forever most grateful to you. I know positively that if I go to Monclair with Father Mackey I will be very unhappy, because I know him, and I cannot predict how long I will be able to stay.

Please excuse my liberty, I opened my heart to you as a son to his father. Let my work then happily for the love of God and the people at Our Lady of Guadalupe Shrine, Riverside.
