BRIEF SUMMARY OF PROBABLE CAUSE:						
On 081312 at about 0200 hours I was contacted regarding a child abuse report that had occurred within the last couple of hours in the City of Woodburn, County of Marion. I responded to the police department and contacted the alleged victim and the victim's family.						
I contacted (V) who told me the following: (V) told me that he had gone to a community church event party with his family. (V) told stated that also present at the party was Father Angel Perez, Priest of the Woodburn St. Luke's Catholic Church. (V) told me that Father Angel had asked his parents a few days prior to take (V) to the mountains for a trip. (V) stated that he was going to spend the night at Father Angel's house after the party. (V) stated that after the party he and Father Angel went to Father Angel's residence located at Street where (V) stated that he and Father Angel watched a movie. (V) stated that they set up an air mattress on the living room floor where he was going to sleep. (V) that stated that he fell asleep on the air mattress and was woken up by a couple of flashes. (V) stated that he fell asleep on the air mattress and was woken up by a couple of flashes. (V) stated that he opened his eyes he saw Father Angel next to the air mattress with a cell phone in his hand and his other hand on (V) stated that Father Angel was grabbing his penis and believed that the flashes were flashes from the cell phone camera of Father Angel. (V) stated that Father Angel was only wearing his underwear and a t-shirt. (V) stated he observed that both his underwear and shorts were down to his knees with his penis exposed. (V) stated that when Father Angel went upstairs, he pulled up his underwear and shorts and went to pack up his things. (V) stated that Father Angel came back downstairs within minutes and lay down on the air mattress. (V) stated that Father Angel came back to him saying, "Come back to bed". (V) told told me that he told Father Angel goodbye and ran out the side door of the residence.						

him in his underwear. (V) said he ran down street he saw that Father Angel was chasing after him in his underwear. (V) said he ran down said he found a couple of people standing in the driveway of a residence and told them "Help me, a guy is chasing me". (V) told told me that he no longer saw Father Angel chasing him at that time. (V) stated that he asked the male adult for a ride to his sister's house in West Woodburn. (V) stated that the male subject gave him a ride to his sister's house. (V) stated that he arrived at his sister's house and reported to her what had happened.
I then spoke with the sister, (O)
On 081312 I spoke with brother (O) at his place of employment. (O) told me that Father Angel arrived at their residence located at street NE, In the City of Salem, and County of Marion at about 0200 hours. (O) told me that Father Angel had a strong odor of alcohol and appeared "intoxicated". (O) told me that Father Angel's first statement was, "I am very sorry; I made a mistake". (O) told told me that Father Angel continued to ask forgiveness and stated "I didn't mean to hurt (O) told me that Father Angel also stated "I am just one who serves in the church and I have sinned; don't stop believing in the church". (O) told me that Father Angel continued requesting to speak to both and his father but they refused to speak to him. (O) told me that Father Angel did not want to leave their residence until the mother forgave him and "gave him her blessing". (O) told told me that while Father Angel was speaking he stated, "Look at my phone, you won't find anything". (O) stated he noted that Father Angel's cell phone was a black colored IPhone. (O) told me he attempted to look at the phone but it had a blinking message stating the cell phone needed to be charged. (O) told me that he then walked over to the door and asked Father Angel to leave once again at which time Father Angel stated, "This is the last time you will see me". (O) stated that Father Angel left at that time.
On 08/13/2012, Detective Sergeant Nick Wilson and Detective Aaron Devoe interviewed Father Angel Perez at the police department. At that time Angel Perez said he was at a community event/party with other people to include the (V) Perez stated he drank too much and became intoxicated. He told me he and (V) were given a ride back to Perez' house in Woodburn. Perez stated he drank another beer, a Pacifico, while at home. He stated he and (V) were watching a movie. He told me at some point he blacked out and doesn't remember what happened. He told Sergeant Wilson that he remembers that he went upstairs and brushed his teeth. He came downstairs and saw the look on (V) face. The look was of "disappointment and anger." He said (V) then ran out of the house and down Street toward Street toward.
Perez stated he drove intoxicated to the (V) house to apologize and find out what happened. During the interview he stated he got down on his knees and begged for forgiveness.
Upon his arrest, (S) Perez was in possession of a black colored IPhone and has not been searched as of the writing of this statement.
On 08/13/2012, Detective Sergeant Nick Wilson spoke again with (V) via phone at which time (V) disclosed that Father Angel Perez also had provided him with a beer at the residence while
