DIRECT COMPLAINT

CHARGING VIOLATIONS OF:

COUNTS 1 and 3: Conspiracy to Commit Sexual Conduct With a Minor, in violation of A.R.S. §§ 13-1003, 13-1405, Class 6 Felonies

COUNTS 2, 4 and 5 : Sexual Conduct With a Minor, in violation of A.R.S. §§ 13-1003, 13-1405, a Class 6 Felonies

The complainant herein personally appears and, being duly swom, complains on information and belief against ORSON WILLIAM BLACK JR., charging that in Mohave County, Arizona:

COUNT 1

On or between May, 1998, and August, 1999, ORSON WILLIAM BLACK, JR., did conspire to commit the offense of: Sexual Conduct with a Minor, Roberta LeAnn Stubbs, who was at least fifteen (15) years of age, but under eighteen years of age.

In furtherance of this conspiracy and to the effect the objects thereof, defendant and Roberta Leann Stubbs agreed that one of them would commit at least one overt act, including, but not limited to: commission of an act of sexual intercourse as defined by A.R.S. § 13-1401.3, all in violation of A.R.S. §§ 13-1003, 13-1405, 13-1401, 13-301, 13-302, 13-303, 13-304, 13-3821, 13-701, 13-702, 13-702.02 and 13-801.

COUNT 2

On or about August 7, 1999, ORSON WILLIAM BLACK, JR., intentionally or knowingly, engaged in sexual intercourse or oral sexual contact with a minor, Roberta LeAnn Stubbs, who was at least fifteen (15) years of age, but under eighteen years of age, in violation of A.R.S. §§ 13-1405, 13-1401, 13-3821, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.02, 13-801 and 13-902.

COUNT 3

On or between November, 1998, and July, 2001, ORSON WILLIAM BLACK, JR., did conspire to commit the offense of: Sexual Conduct with a Minor, Beth M. Stubbs, who was at least fifteen (15) years of age, but under eighteen years of age.

In furtherance of this conspiracy and to the effect the objects thereof, defendant and Beth M. Stubbs agreed that one of them would commit at least one overt act, including, but not limited to: commission of an act of sexual intercourse as defined by A.R.S. §13-1401.3, all in violation of A.R.S. §5 13-1003, 13-1405, 13-1401, 13-3821, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.02, 13-801 and 13-902.

COUNT 4

On or between June 1, 1999, and July 31, 1999, ORSON WILLIAM BLACK, JR., intentionally or knowingly, engaged in sexual intercourse or oral sexual contact with a minor, Beth M. Stubbs, who was at least fifteen (15) years of age, but under eighteen years of age, in violation of A.R.S. §§ 13-1405, 13-1401, 13-3821, 13-301. 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.02, 13-801 and 13-902.

COUNT 5

On or about July, 2001, ORSON WILLIAM BLACK, JR., intentionally or knowingly, engaged in sexual intercourse or oral sexual contact with a minor, Beth M. Stubbs, who was at least fifteen (15) years of age, but under eighteen years of age, in violation of A.R.S. §§ 13-1405, 13-1401, 13-3821, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.02, 13-801 and 13-902.
