Dear Friends:

Since 2004, the Wilmington/Philadelphia Province of the Oblates of St. Francis de Sales has been named in lawsuits in the Superior Court of Delaware filed by 40 plaintiffs, each of which contained allegations of sexual abuse of a minor. In these lawsuits, Oblates, some living and some now deceased, were accused of harmful violations of trust against young people, between 1955 and 1991.

While Delaware's passage of the Child Victims' Act in 2007 led to a total of 40 survivors filing lawsuits seeking justice and reconciliation, the Oblates have been dedicated to the healing of the abused and the protection of young people for many years prior to the enactment of the CVA. Over the years, the Oblates have offered and funded counseling services to anyone coming forth alleging abuse by an Oblate, including members of their families. The Oblates are humbled and grateful for the opportunity to take part in a global settlement agreement with all of the men and women who filed claims against us pursuant to the CVA of 2007. Though healing has begun, more needs to be done.

Toward that goal, the Oblates enlisted the aid of Praesidium, Inc., a secular abuse risk management company that assists organizations such as schools, recreation centers and other groups -- like the Oblates -- who deal regularly with young people. The Oblates work closely with Praesidium, an independent review board, and mental health and childhood abuse specialists in order to ensure that what happened in the past to young people in our care will never happen again.

hurting young people over the past five decades. Eight of these Oblates, not all of whom are priests, are deceased. Four are living in monitored locations, after having been removed from ministry. The men on this list have admitted or substantiated allegations against them. I share their names with you in an effort to inform you as to their assignment history and to their present situation. It is with some hesitation that I have decided to disclose the names of certain deceased Oblates

One step the Oblates need to take today is to share with you the names of 12 Oblates accused of

sorrow or embarrassment that their families and friends may experience as a result of this disclosure. I also regret any further suffering that any of the survivors may endure as a result of being

reminded of their abuse. The abuse of children by priests and other clergy is shocking, reprehensible, and devastating to all whose trust has been shattered by their selfish deeds.






