Deceased or former Xaverian Brothers with an allegation of an offense against a minor (anyone under the age of 18) that could not be fully investigated to determine credibility, but for which there is a reasonable possibility (semblance of truth) that the alleged offense occurred. Reasons a full investigation would not be possible include that the allegation was brought forward after the death or departure of the Brother or that historic information on the allegation is incomplete.
