

1           A.     I'm sorry.  I was 12 -- about 12.

2           Q.     When he penetrated you with his finger, did he  
3 say anything to you?

4           A.     He would just keep telling me that -- he would  
5 just keep telling me that one day he would show me  
6 something else that would make me feel good, that it  
7 would feel good.

8           Q.     Did you tell anything to him when he was doing  
9 this to you?

10          A.     At that point, I would ask him didn't we have  
11 to be married to do stuff like that.

12          Q.     And what would he tell you?

13          A.     He would tell me that no, he couldn't marry me  
14 because he's a priest.  He's 31 years older and can you  
15 imagine what the people would think.

16          Q.     Did you tell anybody after this happened?

17          A.     I tried telling my biological mother.

18          Q.     What did you try to tell her?

19          A.     What he was doing and I would just tell her  
20 that he was getting intimate -- or I wouldn't use that  
21 word -- that he was getting physical with me.

22          Q.     And how did your mom respond when you told her  
23 this?

21 Q. (BY MS. NAVA) What did your mom say?

22 A. She looked at me and she said, "Just don't get  
23 pregnant because your father her kill you."

24 Q. How did this make you feel?

25 A. That she didn't want to hear me or she didn't

16 A. It would occur maybe every other week or so.

17 Q. When he would take you to the rectory, where  
18 was or do you know where the other priest was?

19 A. No, I didn't know.

21 A. I ran into him maybe a couple of times.

22 Q. When Miguel Luna took you there or at  
23 different times?

24 A. When he would take me there.
