PERSONS CREDIBLY ACCUSED OF SEXUAL ABUSE OF MINORS WHO HAVE SERVED WITHIN THE CURRENT TERRITORIAL BOUNDARIES OF THE DIOCESE OF LAS CRUCES

By a decree of Pope John Paul II, the Diocese of Las Cruces was formed on October 17, 1982. The territorial limits of the diocese were defined as the New Mexico counties of Doña Ana, Eddy, Grant, Hidalgo, Lea, Luna, Otero and a portion of Sierra, which had formerly been the jurisdiction of the Diocese of El Paso, the counties of Lincoln, Chavez and the remaining portion of Sierra which had been under the jurisdiction of the Archdiocese of Santa Fe.

The following tables contain lists of persons who have been credibly accused¹ of sexual abuse of minors and who have served in parishes located within the territorial limits of the Diocese of Las Cruces. Table 1 contains the names of persons with credible allegations of sexual abuse of minors related to events which occurred in the Diocese of Las Cruces since its establishment in 1982. Table 2 contains the names of persons with credible allegations of sexual abuse of minors that occurred within the current geographical boundaries of the Diocese of Las Cruces prior to its erection in 1982. And Table 3 contains the names of persons who have worked in the Diocese of Las Cruces, with no accusations in this Diocese, and who have been credibly accused of sexual abuse of minors in a location outside of the Diocese of Las Cruces.

The persons named in the tables have been included because the allegations against them have been reviewed and deemed credible by the Diocese's Sexual Abuse Review Board, which is composed of lay professionals with expertise in law enforcement, mental health, and children's health. In determining allegations against an individual to be credible, the Diocese of Las Cruces is not making a definitive statement as to the veracity of the allegations nor the guilt of the accused, only that the allegations are plausible and have not been shown to be false. By their very nature, these allegations are extremely serious, and only a court of law can determine beyond a reasonable doubt whether or not they are true.

From time to time, the Diocese of Las Cruces may add names to this list as people come forward with new information. Allegations of misconduct currently involving civil litigation will be evaluated by the Review Board once the litigation has been resolved. Any person with knowledge of sexual misconduct with a minor by these individuals or any other past or present clergy or employees of the Diocese of Las Cruces are asked to immediately share this information with your local police or sheriff's department. ¹ The Diocese of Las Cruces has defined a "credible accusation" as "an accusation which at least seems to be true (Canon 1717, Section 1), and/or offers reasonable grounds for being believed. A credible accusation is not manifestly false."
