Assignment History– Rev. John Paul McManus, S.S.

Summary of Case: John P. McManus was ordained for the Diocese of Cleveland in Baltimore. In 1942 he joined the Society of St. Sulpice. He worked in the Archdioceses of Baltimore MD, Washington DC, San Francisco CA, Detroit MI, and Seattle WA. Most of his career was spent as a faculty member for seminaries, including almost 20 years at St. Edward's minor seminary in Kenmore WA. He died in 1986. McManus's name was included on the Archdiocese of Seattle's list January 15, 2016 of clergy and religious with admitted, established or credible allegations against them of sexual abuse of a minor.
