When I left the parish parishioners from San Antonio came to say that Fr. Villa Gomez was taking kids on vacation, to movies, etc. Then there was a rumor: someone asking money from Fr. Villa Gomez or this person would go to the authorities.



Guadalajara, Jalisco April 14, 1994

Dear Monsignor Timothy Dyer:

Greetings from the "Perla Tapatia" of Guadalajara, with hopes that this Easter Season has been beneficial for you and for the entire Archdiocese of Los Angeles.

I hope that you remain in good health because those who possess it, possess a treasure; I am referring to myself, as I am now a bit ill. I received your letter in days past and, once that I left the hospital--you are aware of my admission and discharge from same.

I was happy to receive your letter, but when I became aware of its contents, I was very saddened because of what you said re that the Cardina! will not let me exercise my priestly ministry there in Los Angeles.

This filled me with pain, concern and saddness, as you know, I am 71 years old, 33 of which I worked in the Archdiocese of Los Angeles. I gave the Lord half of my priestly life, and now all I have are memories of California.

Because of my illness--high blood pressure that the Lord has given me, I cannot work, travel by air of land as I would want to be able to, given the fact that I cannot be up and around much, go up or down stairs, because I feel that I am lacking oxygen. I sleep little in the evenings and always sitting up in bed, because I feel that I am choking--and that's how things are with me. I am attaching a certificate from the doctor who is taking care of me.

You asked in your letter what faculties I hold and what am I doing in Guadalajara--if I am exercising ministry in a parish. My response is "yes", I am helping out at the Infant Jesus Parish, located two blocks from my place of residence. I help on Sundays with the 8 o'clock Mass in the morning when I wake up feeling well, without any obligation on my part, because some days I cannot even talk, becaue my head feels very heavy, I am dizzy and I have headaches.

I want you to know that when I came to Guadalajara from Los Angeles, approximately three years ago, I went to see Cardinal Juan Jesus Posadas Ocampo, and put myself at his service. I informed him that I was a retired priest and that I was sick and would not work given my high blood pressure. Cardinal Posadas, may he rest in peace, told me that with the faculties I hold from Los Angeles, I would exercise my ministry, and that give my ill health, and that I couldn't climb stairs, he permitted me to have a small chapel in my house, to celebrate Mass and have the Blessed Sacrament.

I live here in my house, which is also yours, with two sisters who are widows, one of them is in a wheel chair and cannot walk, the other is 85 and I celebrate Mass for her, when I can and have a good morning; I am taking care of them, not only the rent on the house, but also medicines and their needs.

For these reasons I appeal to your Christian charity, which is the same as my Father Jesus, I beg you in the name of Our Lord to intercede for me with the Cardinal, so that he doesn't remove my ecclestical faculties, as without them, for me, sick as I am, it would be the same as a living death.

Because of my illness, I told the Pastor of the Parish of the Infant Jesus, would do me the favor of letting you or the Cardinal know whenever God my Father, today, tomorrow or whenever he so wills, to notify you of my death; I'm not afraid and I am ready and prepared whenever He calls me to accountability.

I am asking you and the Cardinal a big favor--if I die here in Guadalajara, please don't leave me here, but take me to Los Angeles and bury me in Calvary cemetery, with my brother priests with whom I lived for many years.

Late last year I received reports from the Sisters at San Antonio de Padua that there were strong rumors about Fr. Villa Gomez' involvement with children a number of years before he left the Archdiocese. I checked with Fr. REDACTED , who was pastor in those years, and he confirmed that there had been rumors. I was not able to get to their source -- as the Sisters were hesitant to give me names and information. In the end, I told them that should Fr. Villa Gomez apply for summer faculties, I would insist on their cooperation. I then wrote to Fr. Villa Gomez and advised him that faculties could not be extended to him this summer until he meet with me to discuss serious matters that had been brought to my attention.

Through REDACTED DACTED, I received your request for a letter from the Archdiocese so that you can renew your faculties in Guadalajara.







On April 22, we received a phone call from REDACTED Bishop Steinbock had recommended he call.

indicating that

I phoned back and he indicated to me that REDACTED had been abused by a Father Guillermo Gomez when he was assigned at Resurrection Parish in the mid 1960's. I found no entry in our database for such a priest. I promised to check into hit, and asked him to encourage his brother REDACTED to phone the hotline. He said he would encourage his brother, but indicated he was not sure REDACTED was willing to do this. REDACTED added that Father Gomez did hug him and blow into his ear while doing so, and touched him (on clothing) down near his genitals on one occasion. He did not see this as abuse, and indicated that what happened with REDACTED was more than this. Again, I encouraged him to have REDACTED call.

I placed a call to Bishop Steinbock. He confirmed that he had recommended REDACTED call and that this priest was assigned at Resurrection. Bishop Steinbock explained, however, that the priest went by Guillermo, but his name was Nemorio. He also suggested looking him up under the name of Villa. I did so and discovered that this priest had been at Resurrection during that period.

He has been out of active ministry since July of 1990, living in Mexico in retirement.

There is a C-File on Father Villa-Gomez. This speaks of "rumors" and "complaints" about his conduct with children. There are no specifics. Because of these reports, he was informed he has no faculties and invited to return here to Los Angeles in order for the charges to be properly investigated. He never did so. Hence, he has no faculties in retirement. There is correspondence with the Archdiocese of Guadalajara indicating that Father Villa-Gomez has no faculties and should not exercise ministry.

He is still living and receiving his pension. The most recent reports in his file date back to 1996. He had health problems at that time.

Attached is a 2002 document from Father Villa's c-file.

We have recently discovered that Father Villa has returned to the Archdiocese of Los Angeles and is living with his nephew.

Subsequent to this 2002 document, another allegation was received in 2008. At that time it was believed that Father Villa was living in Guadalaja and a letter was sent to the Cardinal Archbishop of Guadalajara notifying him of the allegation. No response was ever received from the 2008 letter.

REDACTED has visited him this month and reports:

Fr. Nemorio has several health complications: he has fallen 3 or 4 times and fractured his left leg every time (when he was recovering from the first fall, he fell again and again... hurting the same leg). On April 22, we received a phone call from REDACTED

indicating that

REDACTED

had recommended he call.

I phoned back and he indicated to me that his brother, REDACTED , had been abused by a Father Guillermo Gomez when he was assigned at Resurrection Parish in the mid 1960's. I found no entry in our database for such a priest. I promised to check into hit, and asked him to encourage his brother REDACTED to phone the hotline. He said he would encourage his brother, but indicated he was not sure REDACTED was willing to do this. added that Father Gomez did hug him and blow into his ear while doing so, and touched him (on clothing) down near his genitals on one occasion. He did not see this as abuse, and indicated that what happened with was more than this. Again, I encouraged him to have REDACTED call.

I placed a call to Bishop Steinbock. He confirmed that he had recommended REDACTED call and that this priest was assigned at Resurrection. Bishop Steinbock explained, however, that the priest went by REDACTED but his name was Nemorio. He also suggested looking him up under the name of Villa. I did so and discovered that this priest had been at Resurrection during that period.

He has been out of active ministry since July of 1990, living in Mexico in retirement.

There is a C-File on Father Villa-Gomez. This speaks of "rumors" and "complaints" about his conduct with children. There are no specifics. Because of these reports, he was informed he has no faculties and invited to return here to Los Angeles in order for the charges to be properly investigated. He never did so. Hence, he has no faculties in retirement. There is correspondence with the Archdiocese of Guadalajara indicating that Father Villa-Gomez has no faculties and should not exercise ministry.

He is still living and receiving his pension. The most recent reports in his file date back to 1996. He had health problems at that time.

We received allegations in 1993 of misconduct dating to 1978-79. Rather than deal with those allegations, you retired and moved to Mexico. You were requested to return to Los Angeles in 1994 and 1996 for investigation of these allegations.

Subsequently a report was received in 2002 and another allegation was received in 2008, both regarding conduct with minors in the 1960's and 70's.

With your return to the United States, it is necessary to inform you of the details of the allegations against you and give you the opportunity to respond, should you wish. I will arrange for one of our canonical investigators to meet with you to explain the allegations we have received and to explain your options. I do understand that your health is not good and you are very limited in your activities. In the meantime, I ask your written assurance that you understand that you may not function publicly as a priest and you will not present yourself publicly as a priest.

I trust that you understand the seriousness of the restrictions placed upon you and that you will abide by these restrictions until they have been resolved by the Archdiocese.

The Clergy Misconduct Oversight Board considered the complaint against Father Nemorio Villa Gomez on August 27, 2008 and January 27, 2010.

In 2008 a woman notified Victims Assistance that in the late 1970s, when her two brothers were altar boys, Fr. Villa Gomez would show them magazines in order to sexually arouse the boys. One brother will not tell what else happened and will not speak to VA. The other brother is deceased. The priest was an extern from Mexico at the time and retired to Mexico in 1990. In late 2009 learned that Fr. Villa Gomez is living with his nephew in Upland (CA). has notified the Diocese of San Bernardino that Fr. Villa Gomez—who is 85 years old, frail and ill—is to have no faculties also reported that no response was received after a 2008 letter was sent to the archbishop of Guadalajara, Mexico informing him of allegations against Fr. Villa Gomez will write to Fr. Villa Gomez reminding him that he has no faculties. Considering Fr. Villa Gomez's age and health status, and since no further investigation or action is pending, the Board concurred with staff's recommendation that the case be moved to the inactive file.
