## Bishop defends transfer

## Some lobby on behalf of priest

At least 40 parishioners of the Our
Lady of the Annunciation Church in
Florence have sent letters to their Florence have sent letters to their bishop expressing disappointment that the temporary leader of their church is being returned to his regular post in Springfield.

While he said he appreciated the letters and sentiments of the parishioners, the Catholic bishop of Springfield today said he will stand by his decision.

by his decision.

The parishioners said they have grown fond of the Rev. James A. Sipitkowski — who for the past month has been filling in for their

ailing pastor, the Rev. Richard E. Wellette — and they do not want to see him leave.

However, Bishop Joseph F. Maguire of the Roman Catholic Diocese of Springfield said today that while the reaction of parishioners is "perfectly understandable," he will stand by his decison to return Father Sipitkowski to his chaplain's post at the Bay State Medical Center in Springfield.

Bishop Maguire explained, "We have to spread the good talent around. When a priest is ordained, he belongs to the whole diocese."

The bishop has appointed the Rev.

Henry L. Dorsch, an assistant pastor at the St. Mary of the Assumption Church at 3 Elm St., as the temporary administrator at Annunciation until Father Wellette returns.

Father Dorsch, who also will continue to direct the Northampton Christian Life Center at 95 King St., has indicated he plans to make no major changes at Annunciation during his temporary stewardship of the church's affairs.

Efforts to contact Father Sinit-

Efforts to contact Father Sipit-kowski were unsuccessful. Father Wellette is recuperating at

Providence Hospital in Holyoke from a stroke he suffered while he was celebrating a Mass Oct. 27.

The parishioners have nothing against Father Dorsch, Bishop Ma-

guire emphasized.

None of the half-dozen parishioners who were contacted today to explain their views about the bishop's decision were willing to discuss the issue publicly.

One woman termed it a "private matter" which should not be publi-

cized.

However, Bishop Maguire confirmed that he has been inundated with letters from the parishioners who clearly do not like the idea of losing Father Sipitkowksi. Although he had filled in for only a month, Father Sipitkowksi had been assistant pastor of Annunciation before being transferred in 1981.

Bishop Maguire said he knows from personal experience the difficulty of leaving a church once an attachment has been made to the

parishioners.

Bishop Maguire said he has answered all 40 of the letters he has received so far. In his responses, he thanks the parishioners for their support of Father Sipitkowksi and also urges them to pray for the recovery of Father Wellette.

"It's nice to hear positive comments about a priest," he said. But Bishop Maguire said it was

But Bishop Maguire said it was clear from the beginning that Father Sipitkowksi's assignment to Annunciation was "very temporary."

Father Sipitkowski has commitments at Bay State Medical Center that he must keep, Bishop Maguire said. "And it wouldn't be right toexpect him to carry on the both duties."

Bishop Maguire also said the pa-

rishioners have emphasized in their letters that they have nothing

against Father Dorsch.

As the temporary "administrator" of the church, Father Dorsch will be responsible for the day-today pastoral duties, which range from managing finances to providing spiritual leadership.
