Assignment Record- Rev. Anthony J. Petracca

Summary of Case: Anthony J. Petracca was ordained for the Diocese of Altoona-Johnstown in 1985. His career is marked by a number of short-term assignments assisting in parishes and, notably, several assignment gaps: 1988-1989 (not indexed in the *Official Catholic Directory*), 2000-2010 (Absent on Leave; reportedly was active at Marmion Abbey in Aurora, IL 2003-2004; appears to have been living at a Salt Lake City, UT parish during his leave 2004-2005), 2010-2012 (not indexed) and 2014-2015 (not indexed). He also worked as a college campus minister and hospital chaplain.

Petracca was assigned to three Windber, PA parishes and three Johnstown hospitals in July 2017 when he was removed from active ministry due to an allegation of "misconduct" with a minor in the mid-1980s. A diocesan spokesperson said law enforcement was notified and that Petracca would be living in a place where he would not be in contact with children.

In October 2023 Petracca was arrested and charged with possession of child pornography and criminal use of a communication facility. He died in August 2024.
