1. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on February 22, 2022 in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

2. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on March 09, 2022 in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

3. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on April 10, 2022 in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

4. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on May 18, 2022 in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

5. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on June 16, 2022, in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

6. For the crime of Rape under Art 266-A Par. 1 of the RPC for the incident that happened on June 21, 2022 in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

13. For the crime of Sexual Assault under Article 266-A Par. 2 of the RPC April 10, 2022 AAA accused respondent Israel to have inserted his fingers in her vagina while they were in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;

14. For the crime of Sexual Assault under Article 266-A Par. 2 of the RPC April 14, 2022 AAA accused respondent Israel to have inserted his penis in the anal orifice of AAA while they were inside Cherry Blossom Hotel, Maharlika Highway, Larion Bajo, Tuguegarao City;

15. For the crime of Sexual Assault under Article 266-A Par. 2 of the RPC June 26, 2022 AAA accused respondent Israel to have inserted his fingers in her vagina while they were in Ara's Hotel Barangay Pengue, Tuguegarao City;;

16. For the crime of Sexual Assault under Article 266-A Par. 2 of the RPC August 29, 2022 AAA accused respondent Israel to have inserted his fingers in her vagina while they were in Kings Man Hotel, Linao Road, Carig Sur, Tuguegarao City;




