Dear Attorney Gagnon:

I am writing to update you on my recent visit with Fr. Fleming at the House of Affirmation in Webster Groves, Missouri.

On June 26th, I spent one hour privately with his prime therapist, Dr. Roger Gennari. Dr. Gennari informed me that Fr. Fleming is responding well to the program at the House of Affirmation, and that he was personally pleased with the progress he had seen over the past several months. We discussed a number of canonical issues, especially with regards to Fr. Fleming's future ministry.

On June 27th, I met with both Dr. Gennari and Fr. Fleming. It was at this meeting that I formally told Fr. Fleming that it was Bishop Gendron's decision that he could no longer effectively serve in the Diocese of Manchester. Based on his sessions with Dr. Gennari, this did not come as any shock to Fr. Fleming, as this is normal procedure in such serious matters. We did discuss how he might be placed in a different diocese after he had completed his in-patient therapy. Working with the House of Affirmation, and only with their approval, the Diocese of Manchester through Bishop Gendron would contact and make arrangements with the Bishop of the Diocese in which Fr. Fleming would serve. We project that this will most probably be in St. Louis, and that he will continue as an out-patient with regularly scheduled therapy sessions with his psychiatrist. However, it is unlikely that this will occur

I informed Fr. Fleming of your concern to develop a memorandum of understanding between your office, the Diocese and himself, and he was made well aware of the full implications of such an agreement. Dr. Gennari was most supportive of the development of such a memorandum, and will cooperate with the Diocese and your office in any manner he can. He has had previous experience with other State and County agencies such as your own in such matters, and he feels that such memorandums can also serve great therapeutic value.

As he had offered, and as you requested in our telephone conversation on Friday, I am writing to Dr. Gennari today requesting that he send you copies of the progress reports he regularly sends to Bishop Gendron and this office.

I had the opportunity to spend several additional hours with Fr. Fleming while in St. Louis, and to speak with him at length concerning his therapy and the consequences of his actions here in New Hampshire. I am pleased that he has made excellent progress, and that he is well aware of the full consequences. He continues to demonstrate to Dr. Gennari and to myself a sincere effort and commitment to the therapy program at the House of Affirmation.

I understand that your office has been most busy over the past several months. However, I would appreciate whatever you could do to expedite the Memorandum of Understanding so this could be forwarded by me to the House of Afiirmation as soon as possible. Be assured of our continued cooperation and assistance in any way that we can.



The Roman Catholic Diocese of Manchester was hit yesterday with four lawsuits accusing the church of failing to protect six children from sexual assaults by priests at four different New Hampshire parishes.

The lawsuits say the priests molested young male parishioners in Manchester, Hudson, Keene and Somersworth from the late 1960s through the early 1980s, and they blame the church for allowing it to happen. The suits are filed against the Roman Catholic Bishop of Manchester Inc.

"The church was complicit in keeping all this stuff buried, with catastrophic effects on the emotional lives of the victims and their families. It has torn them apart," said attorney Mark A. Abramson, who filed the lawsuits in Hillsborough County Superior Court.

Abramson said some of the six plaintiffs he represents came forward after Bishop John B. McCormack in February issued a list of 14 priests who had been accused of sexual misconduct and who had been removed from parish

The four priests in the lawsuits caped. were not on the bishop's list. They are not listed as priests in the Manchester Diocese's current directory.

Rev. Philip Petit of St. Jean the Baptist in Manchester, the Rev. Francis Lamothe of St. Margaret Mary in Keene and a priest who has not vet been conclusively identified who allegedly molested a minor in the Holy Trinity Rectory in Somersworth.

Patrick McGee, spokesman for the diocese, said the church had nothing to say about the lawsuits vesterday because no one had seen them. Nor, he said, could the

were absent from the bishop's list of priests accused of sexual misconduct.

McGee said he would research the status of the accused individuals and respond later.

Abramson, a plaintiff's attorney with Abramson, Brown and Dugan in Manchester, litigated the civil lawsuit by the Grover brothers of Keene against former priest Gordon MacRae in the 1990s. (MacRae is serving up to 67 years in prison on a 1994 rape conviction.)

Abramson said that case was so emotionally upsetting that he was reluctant to handle any more sexual abuse allegations against the clergy. But he felt it was necessary to seek some form of justice for people whose lives have been ruined. "I wish there was some way to hold the church criminally responsible," he said.

In one suit, the three "Doe" brothers and their parents allege a priest "savagely sexually assaulted" the pre-pubescent boys, who were frequently sent to play on the grounds of the John the Evangelist Rectory in Hudson.

Abramson said the parents thought: "What safer place than the rectory?"

In one of the other suits, David Labrie of Manchester alleges he was sexually assaulted from 1979 through 1981 by Petit at the former St. Jean Baptiste Church in Manchester. As a result, the lawsuit says, Labrie "suffered severe and painful physical injuries, devastating and continuing emotional psychological harm and loss of enjoyment of life.'

Jeffrey Theberge of Fremont lodges similar allegations against Lamothe for the years 1979 through 1982.

Plaintiff Thomas Eschmann of Somersworth accuses an unidentified priest of assaulting him at Holy Trinity Rectory in Somersworth from 1966 to 1968. Abramson said the priest was not identified because Eschmann was not certain of the name, but that would be established later.

Abramson said the priest, while wearing his clerical collar, would take boys aside and have inappropriate sexual contact with

The lawsuits to not specify damages sought.

"How much is the destruction of your emotional reserves worth?" Abramson said. ". . . maybe the church can put a figure on it."

The diocese settled the MacRae cases, but only after a bitter fight on technical grounds. Abramson said. The case would have collapsed if Judge Carol Ann Conboy hadn't ruled that the six-year statute of limitations hadn't begun to run until the victims became emotionally aware of the harm that was done to them.

In the end, the church paid, but the amount is confidential.

At least three other attorneys have said publicly they have clients who allege they were sexually abused by priests in New Hampshire and plan to sue.

Abramson said the Manchester Diocese had adequate insurance coverage in the 1990s because there were not many cases here, and he surmises this may still be TO:



Called the DIOCESE OF ST.LOUIS, MO. and MONSIGNOR DENNIS DELANEY called us back, telephone number 1-314-633-2226. MONSIGNOR DELANEY confirmed that FATHER FLEMING was there in his diocese in 1984, at the OUR LADY OF FATIMA PARISH, 4550 WASHINGTON ST., FLORISSANT, MO. Their records indicate that FLEMING requested assignment in ST.LOUIS to continue individual counseling with his therapist, whom he had been seeing at the HOUSE OF AFFIRMATION there.

Further stated that the agreement indicated that FLEMING could stay there for one year to continue therapy and was assigned to OUR LADY OF FATIMA. MONSIGNOR DELANEY also read to me a notation that while FLEMING was there, they did not receive any complaints against FLEMING, and no abuse of children occurred that they were aware of. There is also a notation that FLEMING was to be in restrictive service and could not have any contact with children or young people while he was there.

MONSIGNOR DELANEY stated the reason FLEMING was not welcome at the ST. LOUIS DIOCESE anymore was due to a personality conflict with the pastor at OUR LADY OF FATIMA and that is noted. He also read the letter dated May 15, 1986 which describes this problem to the Bishop of Manchester. This document is missing from our files. MONSIGNOR DELANEY was given my name and address, and would check with the diocese attorney to see if they could send these documents. He did not see a problem with this request and read the letter to me over the telephone.

Dear Mr. Fowler,

Pursuant to our telephone conversation earlier today I write to summarize my response to your inquiry about the file of Father Mark FLEMING, a priest of the Diocese of Manchester, New Hampshire.

As you know Father Fleming came to St. Louis in 1984 to participate in the treatment program of the House of Affirmation here. At the conclusion of that program he requested permission to remain in St. Louis to continue work with his personal therapist. During that time he lived at Our Lady of Fatima Parish in Florissant, Missouri which is a suburb of St. Louis.

Father Fleming's service ended here on June 1, 1986.

The file indicates that we have no reports of any allegations of any kind of abuse by Father Fleming during his time in St. Louis. Nothing of this kind precipitated the decision to terminate his service in St. Louis.

I am enclosing a copy of the May 15, 1986 letter of Auxiliary Bishop Edward O'Donnell to Bishop Odore Gendron of which you spoke and which describes the circumstances of Fatner Fleming leaving the Archdiocese of St. Louis. I hope that this is helpful information.

Dear Bishop Gendron:

As you know Father Mark Fleming, a priest of the Diocese of Manchester, completed his work at the House of Affirmation here in St. Louis in September of 1984. Upon his request and in consultation with you and Bishop Mulvee we extended the faculties of the Archdiocese to Father Fleming for a period of one year so that he remain in St. Louis to complete his counselling with a private counselor and serve at a parish in the St. Louis area. I now write to you after consultation with Archbishop May.

During the twenty months that he has served in our Archdiocese there have been no big problems, and certainly to our best knowledge no hint of a recurrence of the problem that originally brought him here. Nevertheless the pastor to whom Mark was assigned has found the continuation of small problems with Mark so aggravating that he has terminated Mark's residence as of June 1st, 1986. We have informed Mark that the faculties of the Archdiocese of St. Louis will be terminated at that time and we feel that now is the time for him to move on and make a more permanent decision about his priestly future.


