Re: Father Michael Pecharich

She has filed a police report but she just wanted us to know about what happened.

20 years ago, around 1980-81. She was about 17 years old and at a High School retreat from San Antonio de Padua parish.

She and her girlfriends were helping Fr. Michael with a youth retreat. The parish was new. She and her family had moved to San Antonio from St. Norbert's. Fr. Michael asked a core group of teens to help plan the retreat. Fr. Seamus was the pastor. The planning meetings were held at the rectory. There were no problems during the planning sessions. Fr. Michael acted appropriately.

reported that Fr. Michael acted inappropriately during the retreat toward her and others of the high school girls who were part of the team.

She stated that one morning, while she was at the breakfast buffet looking at the muffin assortment. Fr. Michael came up behind her, placed his hands under her arms and starting massaging her, brushed her breasts and then squeezed her "behind". He made comments about her figure and told her she wouldn't be able to keep her figure if she ate the muffins. She noted her observations of this same conduct directed to other girls.

During the retreat, when all of the retreatants were seated on the floor, she observed Fr. Michael place his stockinged foot in between the legs of another high school girl and wiggle his toes. Others observed this and were shocked.

She knows other adults were present, but she couldn't remember whom. There were also members of the young adult group there.

explained that this behavior bothered her but that her real problems stem from being molested by her uncle when she was 11 years old. Three years later her mother referred her to a psychologist. I asked if, at the time she reported the Pecharich incident to the police, she had reported the molestation by her uncle since the statute of limitations has

been extended. She stated she told that agency about it but it had to be reported in another jurisdiction. She hasn't reported yet although she wants to and is trying to get up the courage to do so. I told her about the Victims Witness Assistance available to her when she reported this to the police. We talked a lot about reporting and she agreed that she would do that.

then described an incident that occurred about three weeks prior to our telephone conversation. One year ago the HOPE GROUP out of the Mission San Juan Capistrano parish was helping her. HOPE is a group of lay parishioners who help out struggling single moms. According to San Juan parishioners

At one time last year, (who is gainfully employed now) was out of work and she and her child needed a place to stay. Through HOPE, lived with the buttle buttle she could find employment and afford her own place to live.

She eventually moved out into her current home. The melped her moved there. About three weeks ago on a Saturday night, was home alone.
